



## Virgin Media Business Cycling Challenge Terms and Conditions

1. The organizers of the challenge are Dublin City Council, while the sponsors are Virgin Media Business Ireland
2. The challenge is open to residents of Dublin County, in the Republic of Ireland, aged 18 years and over
3. There is no entry fee and no purchase necessary to enter this challenge
4. The challenge will run from 12am, Tuesday 26th October 2021, until 11.59pm, Sunday 21st November 2021
5. The challenge consists of four separate weekly prize iterations, and a single grand prize iteration that runs for the total length of the challenge
6. All participation for the challenge should be recorded within the Dublin Cycling Buddy (DCB) mobile application
7. Participants that meet the respective weekly/grand prize iteration criteria will be entered into a pool of other successful participants in that category, of which a winner (or winners) will be raffled randomly
8. Participants must on their own, ensure that their activities are recorded correctly within the DCB mobile application to meet the requirements of the challenge
9. The organizers and sponsors bear no responsibility if a participant seeks to claim meeting the requirements of the challenge, while it is not correctly recorded in the DCB mobile application
10. The organizers and sponsors reserve the right to cancel or amend the challenge and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the organizers and/or sponsors control. Any changes to the challenge will be notified to entrants as soon as possible by the organizers
11. The organizers and sponsors are not responsible for inaccurate prize details supplied to any entrant by any third party connected with this challenge
12. There will be no cash substitutes for prizes and no compensation will be payable if the winner is unable to use the prize as stated. If, due to circumstances beyond its control a prize becomes unavailable, the prize may be substituted for a prize of equal value without notice. All prizes, are subject to availability.
13. Winners will be notified via the DCB app to email the organizers on instructions to collect their prizes
14. The winners will then receive an email containing information about the prize and location of the shop, where the prize must be collected
15. Responsibility for the administration of this competition rests with the organiser and the sponsors will not be processing any personal information on behalf of the organiser.
16. The challenge and these terms and conditions will be governed by Irish law and any disputes will be subject to the exclusive jurisdiction of the courts of the Republic of Ireland
